Our township administration is finalizing the plans on the newly acquired land to enhance the Township Marina Complex on Cliff Road and the Redevelopment update in Ward 1. The Redevelopment of Downtown Woodbridge is in full swing with help from the mild winter so far. 10 Green Street developed by PCP Heard's Square has the first two floors sheet rocked and heading to the third. The roof is almost complete as well as the brick façade, PCP placed beautiful decorative light posts on their site that helps to light the sidewalk as well as the incoming retail locations. Modera located directly across the street from Town Hall has been moving at warp speed. Site work remediation and foundation work are taking place simultaneously in order to get the site up and running as quickly and possible. The developer has paved a new welded walking path around the site through the park for improved access from the train to the crosswalk in front of Berkeley College. Vermiela Woodbridge, the project being built at the old Hess property on upper Main Street continues with site work and foundation. The new project will be a mixed use, multi-family development with resort-like amenities and well-thought -out spaces providing functional yet luxurious living here in Woodbridge. The Striking Fist property on Main Street, Middlesex hotel, has been designed to and will revitalize the corner property to provide an attractive entrance to the downtown. They discussed the possibility of a green wall and other upgrades to better showcase attention. Brook Street Lofts are being constructed on the old Stern Tower site. Site work is near completion as well as the foundation work. The new modern building will provide a beautiful addition to the area and finally the township is looking at the construction of two parking decks in the downtown area. The decks will provide necessary parking for the enhanced downtown area. I wanted to thank all our residents for your patience and understanding while these construction sites are being done. Also a special thanks to our police officers for patrolling these areas keeping our residents out of harm's way and for providing particular traffic safety. In addition I've just been informed by the administration that there will be brand new improvements at the intersection of Rahway Avenue and Green Street coming soon. Councilman Ficarra: I have 2 items that I want to bring up that are new on my agenda. First, #12 is the Mental Health and Wellness Initiatives that the town is bringing up. I am happy to report that we are forming a relationship with an organization called Specialized Case Management and Outreach Services. This is in support of Middlesex County. This organization has access to a variety of services that citizens can use. Our services, in particular in the area of Mental Health and also in the area of fighting homelessness, it is Homelessness Intervention. We are also working through them on a training session for our police officers on a variety of ways that they may have to interact with people with Mental Health issues. First of which it is to determine which is an absolute emergency or what the medical people may call acute or if it is not acute and it needs to be followed up, but not immediately. There will be a very significant training session that we are working on now, along with working with what they call the SCMOS group which is what I told you. When the SCMOS group is not in session, which is Monday through Friday traditional business hours, our Recovery Coaches, which are in another department, they work 24/7. So if an issue comes into the PD, our Recovery Coaches will initially take the information from the Police Department and pass it on to the Specialized Case Management folks. So there is no gap or downtime whether it is in the evening or whether it is on the weekend. It doesn't matter; if it happens during business hours once the police are dispatched to the scene, the dispatch will also contact our new affiliates in the county. This is a project that we are working on; it is moving very smoothly and it is moving correctly. Again, this is in support of the police; this is not in lieu of the police. This is just to support the great efforts that they are doing. Now I'd like to take a moment and I don't normally do this, so I don't mess anything up. I want to give you an update on the Covid 19 in particular the vaccine, and the way it is working in Woodbridge Township so please forgive me for reading this, but I think it's important.

Important information including how pre-register for the Covid 19 vaccine via the New Jersey Department of Health Covid 19 vaccine portal; we all have to do that. It has the Covid 19 guidelines and you can access it through our Township website. The township is giving vaccines to people at the Woodbridge Health Center and the original delivery of 1,000 doses will be exhausted by tomorrow so that means by tomorrow we'll have distributed 1,000 doses. The Health Department expects another delivery of 300 more doses later on from this week and also the 500 original people who got their first dose between December 28th and 29th will get their second dose as we move into February. It is important to know and this is the area I don't want people to be confused on, that the Township is not responsible for scheduling people in category 1B which is where we are at now. The State Health Department does that. The category for your information includes people over 65 and people that are 16 and 64 that have specific medical conditions are next on the list. But again, when you say next on the list, it is all related to the doses that we get as a town. The Township Department of Senior Services can help senior citizens register for the vaccine; I have witnessed this myself. In the last few days, we got two people that reached out to me and that I am sure you guys have. If you refer them to the Senior Services, they will guide them along and they will even go on the computer with them and guide them through, because no matter who you are, if you are a senior citizen like me or anyone else, you are going to get on that portal and register. For your information again the hotline for this assistance is 732-726-6264. As of now the Senior Center representatives have contacted just about everyone that have called and left a message and will continue to do that. A special thanks, I personally want to thank the Senior Coordinators Liz, Rosemary, Sandra and their Supervisor Cynthia for doing a great job so far. Please again remember that the Senior Center's coordinators nor the Health department representatives can't offer any advice on whether you should get the vaccine or not get the vaccine. I'd like to close with two things: #1 Please do not just show up at the Health Department; they don't control those things. They are very busy, they are distributing what we have. Please go to our website, register on the portal and we can assist you. The final thing is rather obvious, please be patient. Everybody is working at warp speed right now and they are doing the best they can. But we all need to put our patience hat right now and just work with the system as it goes. I am sorry for being so long. I just thought it is important and I read it the way it was written. Thank you.

Council President Small: It is very important to get that out to our residents and they are all doing a fantastic job down there, thank you. Councilman Patel.
