Councilman Ficarra: Moving over to the area of Mental Health. A report from Dr. Bonnie Nolan, the crisis intervention training for the police is now in effect and it is going through, and currently being administered. Dr. Nolan will be attending the musters which is the meeting for the Police Department as they go out on their details and their shifts to review the aspects of the crisis intervention training.

Moving over in the world of legislation. As we know the marijuana legislation has been stipulated that in some cases, minors must receive treatment. If they are caught, there is a discussion now between the PD and Dr. Nolan's department on the proper way to go through that. We have a 10 new certified peer recovery specialists through a grant so that just widens the scope of our program.

And then finally, I just wanted to share a story that I was made aware of because of my involvement in the YMCA. Not this week that we are in, but last week, our Police Department received a call to go out to an area where it appeared to be someone living in the car. It turned out to be a mother and some children going through some difficult times and the mom had just gotten a job, I believe with Amazon. The Police Department went out of their way to make sure that this woman was safe at that time with her family. Actually, went out of their way to get them a room to stay in because this happen on a Wednesday, and their appointment through the YMCA was on Friday, so there was that gap there. The PD took it upon themselves to get this woman into some help until she got into the family service system which she did, and things are moving in the right direction. I can't say that it is perfect right now, but it is moving in the right direction. All because the police took the time to do that extra step. Thank you Council President.

Council President Small: Thank you for sharing that.

Councilman Ficarra: You don't hear that in the news too much, that's why I wanted to take the time to do that. And of course, nobody on the PD Department will tell me who the officers are, but I would think that is a regular thing for our guys.

Again this is for seniors 75 and older for some assistance through the State program 856-249-7007. We know by most of our media outlets that the governor has announced expansion of eligibility starting March 15, educators and those involved around education throughout has access if they haven't already along with a series of other people including public safety workers, migrant farm workers, tribal communities, and the list will go on as it expands.
