Council Vice President Bauer made a motion that these Ordinances be taken up on Second and Third Readings and for the public hearing to be opened which was seconded by Councilman Ficarra and carried unanimously.

Council President Small moved the public hearing to be held on these Ordinances and carried unanimously.

Ken Gardner, Woodbridge: Asked for more information on Ordinances B, C, and D in regards to the Downtown Redevelopment plan - if these are residential properties, if this is a taxing district like the Special Improvement District, if this is part of the SID, if there is an intention to add it to the Special Taxing District, if the town is doing this to acquire the residential properties, if the houses of current home owners living in, and the not rental properties are included into the plan. Commented on the Planning Board Meeting, the Redevelopment Zone of New Street, his concern about the acquisition of some properties with maintenance issues, his happiness for the adjustment made by the Planning Board based on his comments, asked the business administrator if he is not sure of what the plan is yet, and if the difference on Ordinance D is for the different streets.

Business Administrator Cimilluca: Explained that there are different areas in Downtown Redevelopment plan in which parcels are being added along to make it a complete project to be able to continue with the plan offered to the Planning Board: Ordinance B – area 4 is North James Street, Ordinance C - area 5, Fulton Street. They are amending the plan authorizing the addition to a mixed parcel, that is business and residential, and Ordinance D is also the same as C. All these areas are part of the Downtown Redevelopment plan, are not part of the SID, and at this time, there is no intention to add this plan to the Special Taxing District. Mr. Cimilluca responded that they are doing this for the improvement of the areas, explained that there is going to be a redevelopment section within those areas and said: "the developers will set forth the plan, and then they can afford to make a determination of what they are going to build in that area." Continued responding that depending on the area, some are renters or some are businesses, that this is only for the approval of the plans, and not for the acquisition of any properties at this point, and that he can submit and OPRA request. Lastly explained that Ordinance D - Cutters Dock Road is an Industrial Commercial Property.

Council Vice President Bauer moved the public hearing closed and these Ordinances be adopted and submitted to the mayor for approval, which was seconded by Councilman Ficarra and carried unanimously.

James Dabrowski, Woodbridge: Spoke about how Mayor John McCormac has skipped the meetings, passed them by on February 16th after the meeting was adjourned, and has turned his back when Kason Little said: "Black Lives Matter." Spoke how President Small and Councilman Spillar have also turned their back to Mr. Little on March 3rd 2020 Council Meeting, and refused to apologize for these disrespectful, unprofessional, and racist acts. Spoke about how the Woodbridge elected officials have ignored the Woodbridge Youth for Liberation and Equity members, and have not met to discuss anti-racism initiatives with them, how Mayor McCormac resurrected the Human Rights Commission, and how Council President Small still refuses to meet virtually with WYLE whose members feel uncomfortable to meet in person due to the pandemic.

Spoke about Nijeer Parks and the civil rights lawsuit against the Woodbridge Township, zero cultural competence, the Mayor's legacy, the Independent Club of Colonia virtual Black History celebration, Amanda Gorman's poem, Woodbridge student Michelle Henderson, President Joe Biden, black Vice President Kamala Harris, how Council President Small is afraid of transparency, and asked him again why he would not meet virtually with WYLE.

A short discussion followed between Council President Small and Mr. Dabroswski.

Then talked about Mr. Tanzman's foundation, the donations made to various community groups and civic things throughout the township.

Continued speaking about James Keating's 50 years of dedication and volunteering to the youth, his accomplishments, achievements, and the proper recognition he should receive for any event at the James Keating Park basketball court.

The Woodbridge Cable Commission has requested proposals to each cable provider in New Jersey. However, no other company has submitted any proposals. Comcast does not

have an exclusive contract with the township, and we are free to enter into an agreement with any other cable provider. I know we hear from residents frequently about Verizon Fios. Verizon originally stated that they were installing Fios in most built towns and Woodbridge was not recognized by them as one of the possible built town. Verizon has a statewide franchise agreement so they do not need a permission to start wiring and providing service, but they have not committed to the township and they are slowing down now. New construction all over the state. The Township and the cable commission has no official input with regards to pricing, channel availability, internet, and usage plans. While we have been quite vocal with the BPU and Comcast, and our frustration with some of their decisions. At the end of the day per state statute, the BPU of public utilities are the entity responsible. The Township and Cable Commission will continue to try to entice new cable providers into the township. I understand from the residents, it is frustrating. I get frustrated. I am sure that we all gotten frustrated. We all use Comcast at some given point. We are trying, but our hands are tied, so much with the board of public utilities. Councilman Ficarra: The Mental Health Initiative and Dr. Nolan. She attended 10 Woodbridge Township Musters. These are meetings that the Police Officers have before they go out in shifts. Every officer is now aware in the Police Department of the Mental Health protocol. The key takeaway is that we are working to ensure a warm handoff when the officers come across someone in need of Mental Health services in the county regardless of the time of day or the severity of the call. Police are called daily and referred at least one person every day since the start on March10th. So that's not good news, but it is good news that the process is working, and we are beginning to achieve our goals of assisting people that need help. Dr. Nolan's Department is just finishing up a cycling grant for a grant called reset which offers assistance with employment, training for employment workplace readiness through Middlesex College and that assisted 200 people during this funding cycling. So we are happy about the assistance that we are offering people that could use it the most, and basically that's all I have Council President. Thank you.

As I've said now for the last two or three meetings, I first asked you to register with the state and the state alone. Now we strongly suggest that you register wherever you can, and keep an eye out for those on the Walgreens, CVS, and Rite Aid.

Council President Small: Thank you. I was over the Health Center the other day. I took two seniors over to get their shots. I ran into the Mayor. He told me that there is a resident, and he might have talked to you about it. There is a resident; he did not give his name, but gets up at two o'clock in the morning, and reserves spots for people in need. Then gets up at four o'clock, and does the same thing for other residents of the town. So, it is a really great gesture.

Councilman Meehan: I have to add to that to. We have somebody in Colonia who does that too that we heard, and it is not just Colonia. There is a lot of people throughout the township that are getting all these CVS's and they are really trying to help these seniors in their spare time.
