Gloria Landi, Woodbridge: Into what Sir?

Councilman Cory Spillar: It is up to every redeveloper...

Vito Cimilluca: The plan has not been announced yet or hasn't been formulated. It is just to redevelop the area because it's dilapidated.

Councilman Cory Spillar: In order for us to send it out for redevelopment, we have to pass the Ordinance since it is in the redevelopment zone.

Council Vice President, DeJesus: Madame, can you go back into the ropped area and speak into the microphone and just tell us your name and what part of the township you are from please.

Gloria Landi, Woodbridge: My community is very concerned about the development that's going on around us; this is on Route 1 and I want to know on what proximity of Route 1 is that Sharon Gardens is for development. I understand that there is a lot of construction there and we want to be developed. That's fine, but we have horrendous traffic problems now on Woodbridge Center Drive and you are going to landlock us.

Councilman Cory Spillar: This is the area between Wiley and Lord Street. So if you turn at the firehouse and make a left, the motel is right there on the right inside.

Gloria Landi, Woodbridge: Right side, okay. My question is the development that is going on where the solar field was?

Council Vice President, DeJesus: I am sorry this has nothing to do with this ordinance.

Gloria Landi, Woodbridge: okay.

**Mr. John Mitch:** Can I get a motion to approve 44 Resolutions by consent?

Council Vice President Small moved the adoption of the foregoing Resolutions. The motion was seconded by Councilman Bauer and carried unanimously.

**Council President, DeJesus:** We will now move to the public portion of the meeting, please approach the microphone if you would like, state the area of the township you reside and your name, there is a one time, five-minute time period and again, if you wish to record the meeting, you have to go in the corded blue area.

#### **Public Meeting:**

**Mr. John Mitch:** Anybody from the public, have any comments?

Gloria Landi, Woodbridge: Spoke about her concerns on the traffic pattern and how she called the police and did not receive the answer back on. Also spoke on the traffic lights going into Woodbridge Center and into Wegmans, and wanted to know the number of units on the development going on down the street, where the solar field was, if they were low income or if they will have a certain percentage of low income housing. Next she spoke on how her very diverse community have great concern on Black Lives Matter and don't want to see riots. Said that all lives matter and how she is not in favor of police defunding. Lastly, she said that "however listening to all of you who have concerns, which are very valid, as long as they remain peaceful and loving to our community because we have a good community."

Mr. John Mitch: Are there any comments this evening from the public?

Council President, DeJesus: I don't know if there is people lined up outside, who wants to come in and speak, so I am going to ask the same time as the last meeting. If you are done talking, can you please give up your seat to someone who is coming in to speak? I would like to make room for everyone to get a chance to speak so all I am asking to everyone is that once you are done speaking, if you don't mind getting up, they did it last time with no issues, just get up and give up your seats to let someone from the outside to come in. You can always watch our Council meetings on Channel 35 so that you can hear everything that is being said.

Charity Daramola, Sewaren: Spoke about how she is in favor of the complete removal of Police Officers in Woodbridge Township School District Schools and how to protect these kids: "The Schools are places of learning not places meant for confinement". She added how these Police Officers should be replaced with trained specialists who can deal with conflict, understand the real and mental health issues students are going through, their problems and struggles, and who can approach them with care and love.

**Council President, DeJesus:** Anything that has to do with the schools, you have to go to the Board of Ed. We heard you but again, they make the decisions so you have to go to the board of Ed.

Mary Nasr, Port Reading: Spoke on the lack of accountability, on police brutality and misconduct in this town and the need for transparency. Said also how Patricia Mendez was approached by a police officer while waiting to pick up her son, how Jeffrey Gutierrez was falsely accused, arrested, and later on given \$125,000 to stop pursuing the case in court and how three black women were awarded \$70,000 after a police encounter. Ms. Nasr is in favor of sharing publishing yearly data relating to arrest force, traffic and violations in Woodbridge with residents.

**Audra Sabara, Metuchen:** Spoke how she works as a social worker, eat and spends money in Woodbridge Township and how she also supports Black Lives Matter. Mentioned being member of the Metuchen accessibility Committee and the lack of resources in social work in Woodbridge.

**Mr. John Mitch:** Are there any other comments this evening from the public?

Jimmy Dabrowski, Woodbridge: Talked about the racist problem in Woodbridge, the white supremacy violence, the need for symbolic commitments with the Woodbridge Youth for Liberation and Equity in anti-racism, anti-racism scholar Dr. Ibram X. Kendi, author-activist Ijeoma Oluo and Tony Gallo. Mr. Dawrobski said: "You should all be ashamed that you are standing with this people on the wrong racist side of history instead with the community members of conscience on the right anti-racist side. I know the Mayor is worried about pissing off half the town, and not getting re-elected, to use his own words, but it is at the cost of his conscience and yours too, if you are too cowardly to challenge him for once, and actual serve as a Council of checks and balances, rather than just a group of yes people or giving him a rubber stamp or whatever he wants, and whatever the Woodbridge PBA wants and that goes for the Mayor's hand-picked Human Rights Commission also." spoke in favor of defunding the police by 15% and having the most resources. Finally said; "My one wish is that you finally begin to make concrete commitments to anti-racism and that you work with our brilliant Woodbridge Youth for Liberation and Equity"

**Council President, DeJesus:** Disputed Mr. Dabrowski for calling them racists and spoke about how she supports the Police Department, Black Lives Matter, the Woodbridge Township and the Latino Community.

**Mr. John Mitch:** Are there any other comments this evening from the public?

**Council President, DeJesus:** And again if you made a comment and you are done, please allow anyone else to come in, have a seat and what they have to say.

**Mia Banks, Avenel:** Member of Youth for Liberation and Equity Spoke how she is in favor of defunding the Woodbridge Police, how she supports policies to help black people in the community and also about her email on racism in Woodbridge and the Racist Housing policies in 1965. Said: "We are asking you guys to look into the problems of Woodbridge and find out the solutions that need to be made so that we can support all the different areas of this country that we need to support." Then, spoke how she is not in favor that population growth in 2021 requires for more police and on the relationship between police presence and the levels of violent and non-violent man in Woodbridge. Mentioned about how they will utilize media outlets to expose the truth about Woodbridge on Instagram and Twitter

Mr. John Mitch: Are there any other comments this evening from the public?

Council President, DeJesus: Regarding the reason of why we haven't had a Town Hall is because of Covid-19. The Governor decreased the number, and if you notice, there are 2 less seats here because of his decreasing to 25 people in an indoor. If you are going to have a town hall in an indoor, we have to abide by the social distancing and by the things. It wouldn't be a group of people; it would just be limited. So that is why we haven't made a decision, as to whether we are going to do that or when we are going to do that, because we keep waiting for things to open up.

**Speaker:** What about a virtual Town Hall like Zoom? Is that an option?

**Council President, DeJesus:** We don't do Zoom Council meetings right now, and because we don't do zoom meetings, I am going to say no.

**Speaker:** I know, but other towns have them...

**Council President, DeJesus:** I know, but we made our decision as a Council not to have them.

**Speaker:** We are asking to re-evaluate that decision. Bend the rules, so you can accommodate for all of your residents, especially residents of color. You can do an outdoor town hall, and it also be accessible for people with disabilities.

Councilman Greg Ficarra: I just want to make a statement. I know Mr. Dabrowski does not seem to be in favor of Human Rights Commission. I believe Meshal and other members of the WYLE will have the ability to speak to them, and although I don't speak for that group, because I am not on it, I think their intent is to gain this knowledge. They are monitoring everything that you are doing, and hopefully at some point, your group will connect and be able to speak. And their whole intent to that Commission was to give us guidance. That Commission was put together in part because of the efforts of most of your people. So, something is getting done, probably not fast enough for you, but something is getting done, and on its own. I don't think I am speaking out of school here, but I think most of you know that Kyle Anderson also has an organic kind of community group, that many of the WYLE, not many, but I recognize some of the names because my technology is not very good, and I am generally on the phone and not on my iPad. But those are things that have happened because of your efforts. Now Brandon, I understand, they are not happening fast enough, but they are happening, and I think you will be able to have an opportunity to mesh with and continue to express. I know they are listening, but I think there are needs to be more face to face. I intend to agree with you on that issue, but I just don't want to sit here and think that nothing is being done. I don't want to say that when you are speaking and I speak or we speak, we are taking your five minutes. So out of respect to you, this time that I am speaking, it is not taking away any other time. Council President, thank you. I hope I am not speaking out of school Councilman Anderson.

**Meshal Avenel:** Spoke about how he was blocked on Twitter by Councilman Spillar, and how people empowered in this town bare minimum accountability. Mentioned about the Human Rights Committee reestablishment.

"Due to the loss of power and/or a power surge that resulted in Town Hall moving to back-up generator power, TV-35, as well as the Council audio recording system, was able to record only the first 41 minutes of the Council meeting - audio connection for the remainder of the meeting was lost due to the loss of power and/or power surge resulting from storm Isaias.
